Re: Opposition to the Executive Amnesty Prevention Act of 2014 (H.R. 5759)

Dear Representative:

We write on behalf of the National Hispanic Leadership Agenda (NHLA), a coalition of 39 leading national Latino nonpartisan civil rights and advocacy organizations, to urge you to vote against H.R. 5759, the Executive Amnesty Prevention Act of 2014, and any similar legislation that would repeal or impede the implementation of President Obama's recent series of administrative actions to address some of the most immediate and damaging flaws in our immigration practices. Furthermore, we strongly encourage you to pass an omnibus appropriations bill that funds *all* aspects of government, including the Department of Homeland Security and other agencies charged with implementing the President's executive actions.

NHLA's mission calls for unity among Hispanics nationwide to provide the Latino community with greater visibility and a stronger voice in our nation's affairs, including the pressing need to reform our nation's badly broken immigration system. NHLA will closely monitor the result of these votes and may include votes on, or in relation to, bills seeking to restrict administrative actions regarding immigration enforcement in future NHLA congressional scorecards or other informational outreach efforts.

On November 20, 2014, President Obama announced a series of Immigration Accountability Executive Actions, which apply the Executive's inherent constitutional and administrative authority to make changes to our nation's immigration enforcement practices. Among these actions was an expansion of Deferred Action for Childhood Arrivals (DACA), a program of deferred action for parents of U.S. citizens and lawful permanent resident children, and termination of the ineffective and counterproductive Secure Communities program. While such actions are limited in scope, they represent a critical and long overdue step to reduce some of the suffering caused by our dysfunctional immigration system.

Legislation that would impede the Administration's ability to fully implement its Immigration Accountability Executive Actions would subject millions of individuals to potential deportation and continued exploitation. Furthermore, if enacted, this legislation would cause irreparable and disproportionate harm to Latino families, who are the primary recipients of current and future grants of deferred action. These bills would also harm the economy by perpetuating the anti-competitive deviations in the underground economy. Instead of attempting to cripple the Administration's attempts
