devastating impacts on Blacks and indeed, all of our *gente* and they must be challenged in all of its iterations from the criminalization of our presence, the profiling and mass imprisonment of our bodies, the biased adjudication of our cases, and the denial of our rights after release from caged confinement. The NHLA platform in this area begins that process.”

### **Economic Empowerment and Labor Committee:**

“Accounting for a \$2.3 trillion economy that will continue to grow, Latinos are integral to our nation’s economic prosperity,” **said Eric Rodriguez, Senior Vice President for Policy and Advocacy for UnidosUS.** “As we have seen during the COVID-19 pandemic, Latino workers are taking the lead in ensuring that our country remains fed, healthy, and moving forward. More than ever, it is in our national interest for policymakers to empower Latino communities with the resources and investments that have been afforded to previous generations of Americans.”

“The Public Policy Agenda calls for an end to the longstanding discrimination that denies farmworkers – the large majority of whom are Latino – the same employment-law rights and protections applicable to other workers,” **said Bruce Goldstein, President of Farmworker Justice and Co-Chair of the NHLA Economic Empowerment and Labor Committee.** “It also identifies many improvements in government programs that are important to the health and well-being of farmworkers and their families. Federal and state policies designate farmworkers as ‘essential workers’ for the nation’s food security during the COVID-19 pandemic but now must provide them with a greater measure of justice.”

### **Education Committee:**

“It’s important that public discourse of the policy and programmatic concerns on Hispanic student success and Hispanic-Serving Institutions be included in party platforms,” **said Antonio R. Flores, President and CEO, Hispanic Association of Colleges and Universities.** “The economic competitiveness of our nation depends in great measure on the educational attainment of the Hispanic community.”

### **Energy and Environment Committee:**

“We are facing an existential climate emergency that must be addressed now and the National Hispanic Leadership Agenda’s 2020 Hispanic Public Policy Agenda contains our most ambitious and comprehensive Environment & Energy positions to date,” **said Mark Magaña, Founding President & CEO of GreenLatinos, a national network of Latinx environmental and conservation advocates.** “Latinos in the United States and abroad are suffering the devastating impacts of extreme weather in increasingly polluted environments. #### **Government Accountability Committee:**

The result is that candidates can draw on the 2020 Agenda to make more thorough diversity commitments and that the next administration now has a clearer roadmap to the important work of inclusion."
